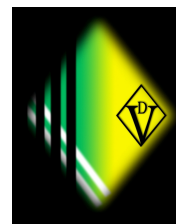

- ✓ In consideration of and as a condition of acceptance of my membership of the Diamond Valley Athletic Club Inc. (the Club) for myself, my heirs, executors and administrators, I hereby waive any claim, right or cause of action which I might otherwise have for or arising out of the loss of my life or injury, damage or loss of any description whatsoever which I may suffer or sustain in the course of or subsequent upon my entry and/or participation in any event organised by the Club.
